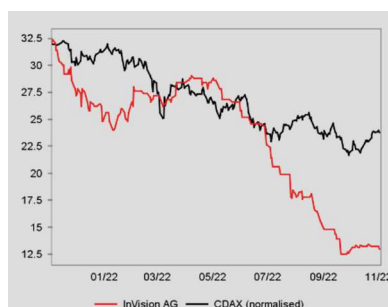

The decisive factor in the reported revenues was that, as of September 30, the injixo ARR (Annual Recurring Revenues), the annualized revenues from injixo cloud subscriptions, increased by 27% compared to the previous year to EUR 7.8m (EUR 6.1m). Besides the reported revenues, this shows that the company's expansion is on the desired path while the structure of revenues is slowly changing. On this basis, the company is sticking to its announced growth plans and intends to expand its workforce to up to 500 employees by the end of 2025. Total sales are set to expand to EUR 50m (WRe: 26m, EUR 50m expected for 2029) and the EBIT margin to 25% (WRe: balanced, 25% expected in 2029).

However, a significant change was made in connection with the valuation of the share (WRe, DCF). The beta, or the expression of the risk adjustment in the model, was increased from 1.7 to 2.0. The reason for this is that the company is currently facing a high increase in costs and significant growth steps are to be expected over the longer term. This makes the entire model very susceptible to economic fluctuations in the medium term, triggered for example by recessionary tendencies in the current economic environment.

The stock continues to be rated Buy with a price target of 22 (29).

The special accounting for software rights leads to a change in the expected taxes (and thus EPS). This has no significant impact on liquidity or the DCF model. The medium-term EBIT forecasts (WRe) continue to assume a gradual, but significant, increase in sales with the acquisition of additional cloud customers. EBIT follows this development closely, but with clear latency.

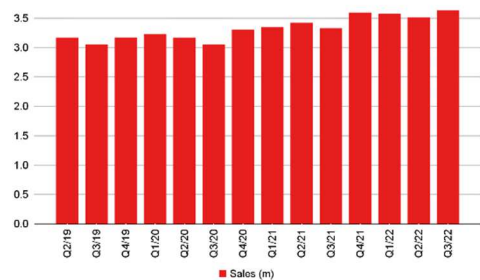

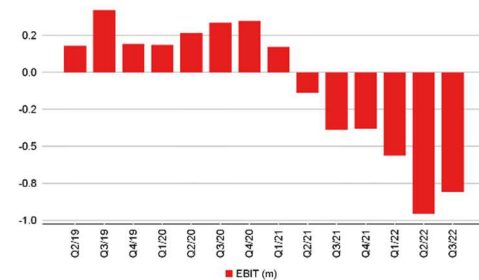

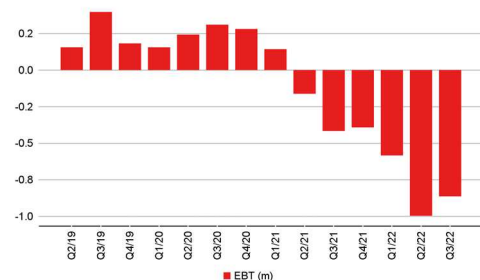
Company Background

Competitive Quality

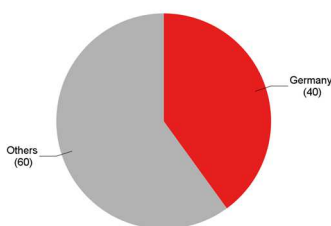
- InVision has many years of experience in the call centre and WFM field

in EUR m



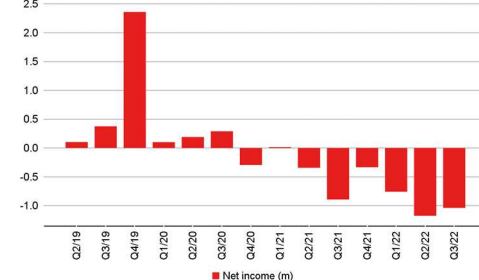

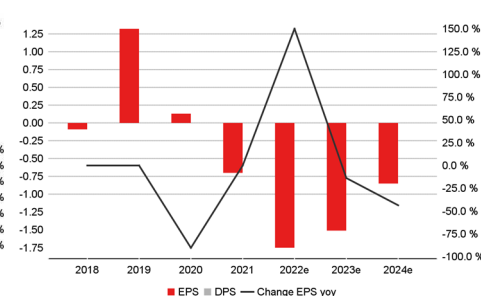
Sales, EBITDA

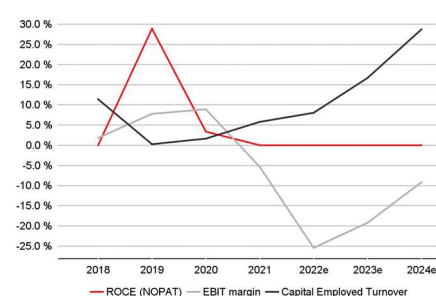

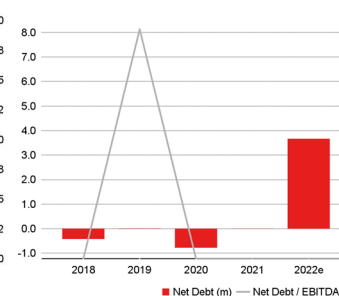

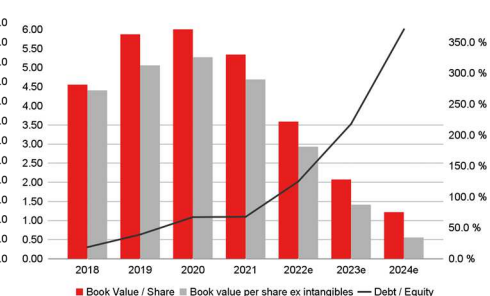
ROCE Development

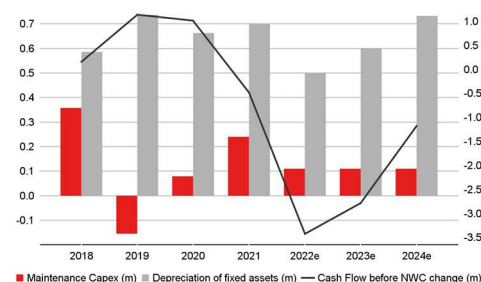

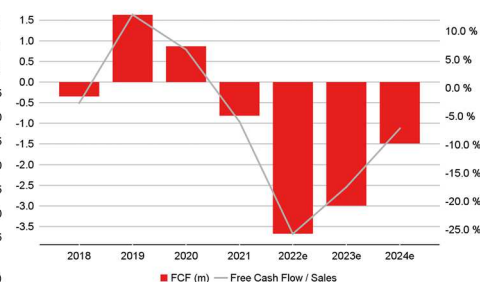

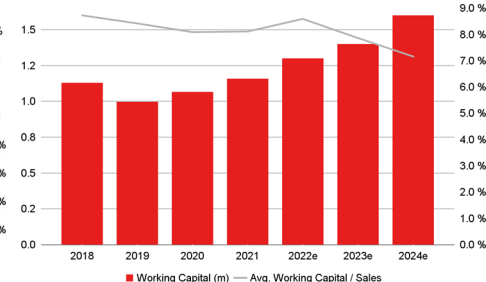
CAPEX and Cash Flow

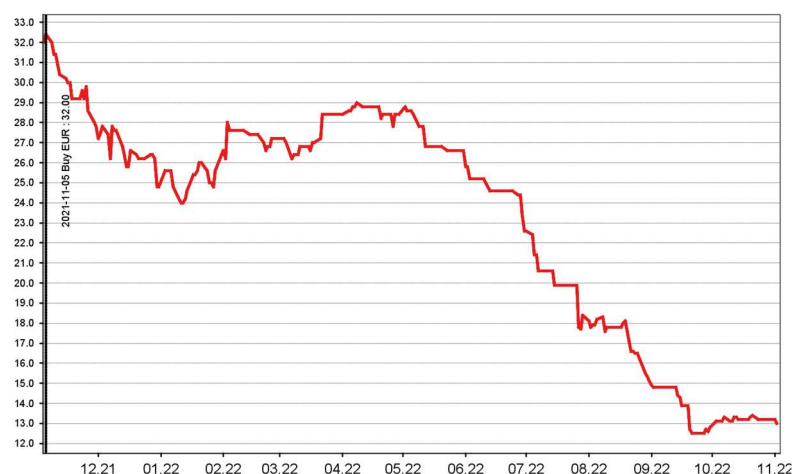
